CERTIFICATE OF LIMITED WARRANTY

The Manufacturer, REMCO INDUSTRIES INTERNATIONAL, INC., warrants their products to be free from defects in material and workmanship under normal use and service for a period of one year from the date of shipment, from our factory in Fort Lauderdale, Florida, except as otherwise specified herein.

This warranty applies only to the original purchaser of this equipment and is limited to original installation made within the continental United States (Alaska and Hawaii being excluded) unless otherwise authorized in writing by Remco.

REMCO INDUSTRIES agrees to repair or replace, without charge a part which is proven to its' satisfaction to be defective during this one year period, provided Remco Industries receives written notice of the warranty claim, sent certified or registered mail, return receipt requested, within said one year period accompanied by the part replaced which will be inspected by the appropriate party whereupon a determination of it's condition will be made as to whether it qualifies under warranty, if so, the charges that were made for said part(s) will be promptly refunded.

For all other service Remco Specialty Products Co. can assist the Purchaser in selecting a qualified serviceperson/company at the request of the Purchaser and offer factory technical services telephonically. Should the Purchaser request a factory technical person to visit the installation for any reasonable reason, Purchaser shall fund, in advance, said visit including time, air travel, overnight accommodations, meals and miscellaneous expenses related thereto. An estimate of expenses will be provided and any surplus funds will be promptly refunded. NOTE: ONLY authorized service persons as aforementioned should be utilized for appropriate service calls and they must be approved by the manufacturer. Purchaser must notify Remco prior to service performance to qualify for warranty claims. Service persons must be authorized by the factory, in writing, prior to service.

This warranty does not apply to or cover damage to equipment, or parts thereof, resulting from accidents, alteration, misuse, abuse, negligence, acts of God or other casualty, failure to properly service and maintain equipment, failure to install, maintain and operate in accordance with instructions, failure to supply proper utilities such as a dedicated 110 VAC electric circuit and adequate gas pressure and volume, tampering, damages in shipment or to equipment serviced by an unauthorized service agency or personnel.

This warranty does not extend to normal maintenance items, including but not limited to air and gas adjustments, adjustments to burner igniters, door mechanisms, replacement of motor brushes, light bulbs, pilot lights, fuses, tightening of gear chains, adjustments to burner flame and tightening of screws or fasteners or other parts consumed under normal operation.

Remco Specialty Products Co. may on a case by case basis arrange the checking out of all new equipment after installation including start-up of the equipment and the necessary gas adjustments as specified for the installation and shall conduct a use and maintenance seminar unless other arrangements are made in writing.

Notwithstanding anything contained herein to the contrary removable parts in Remco products excluding igniters, ceramic parts, cooking stones and electronics are guaranteed for a period of one year from the date of factory shipment.

Any repair or replacement under this warranty does not constitute an extension of the original warranty for any period of the appliance or for any component or part thereof. The liability of Remco or it's affiliates on any claim of any kind, including claims based on warranty, expressed or implied, contract, negligence, strict liability or any other theories shall be solely and exclusively the repair or replacement of the parts as stated herein, and purchaser specifically renounces by acceptance of Remco Products any rights to recover special, incidental, consequential or other damages of any kind whatsoever, including, but not limited to, injuries to persons or damage to property, loss of profits or anticipated profits, or loss of use of the product.

THIS WARRANTY IS IN LIEU OF ALL WARRANTIES OF MERCHANTABILITY, FITNESS FOR PURPOSE, OR OTHER WARRANTIES, EXPRESS OR IMPLIED, EXCEPT OF TITLE. CORRECTION OF NON-CONFORMITIES, IN THE MANNER AND FOR THE PERIOD OF TIME PROVIDED ABOVE, SHALL CONSTITUTE FULFILLMENT OF ALL LIABILITIES OF THE SELLER TO THE BUYER, WHETHER BASED ON CONTRACT, NEGLIGENCE OR OTHERWISE, WITH RESPECT TO OR ARISING OUT OF SUCH SALE.

The initial purchaser must complete all warranty documents and comply with all the instructions furnished with Remco products at the time of delivery or this warranty may be invalidated by Remco.
