



## **Two Year Limited Warranty**

SPI warrants this equipment to the original user against defective material or workmanship for a period of two years from the date of purchase on repair parts and labor. SPI'S responsibility under this warranty is limited to the repair or replacement of defective part or parts. SPI reserves the right to determine whether the part or parts failed because of defective material, workmanship or other causes. Failures caused by accident, alteration, misuse or improper packaging or purposely damaged or attempted to repair or returned units are not covered by this warranty. All warranty repairs must be done by an Authorized SPI Service Representative. Any repair to the equipment other than by these authorized facilities voids this warranty. The rights under this warranty are limited to the original user and may not be transferred to subsequent owners.

### **This limited warranty:**

- Is subject to the disclaimers and limitations described below.
- Gives you specific legal rights. You may also have other rights that vary by state.
- Does not extend to products that have been improperly used, altered, or repaired by any unauthorized entity.

### **Exclusive remedy and claim procedure:**

- Distributors of record must act as a return agent.
- The exclusive remedy under this Limited Warranty for products determined to be deficient in materials or workmanship by SPI is repair or replacement with a reconditioned tool of equal value.
- The selected remedy is at the sole discretion of SPI. In no event shall SPI or its agents be responsible for more than the original purchase price of the product.
